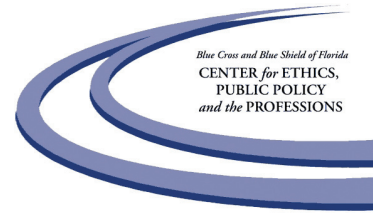

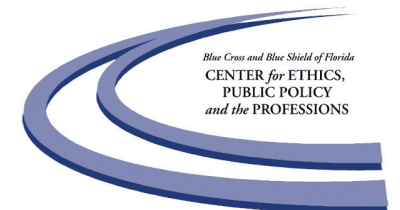

Overview

Wolfson Children’s Hospital, in partnership with the University of North Florida and the Florida Bioethics Network, presents the Fifth Annual Pediatric Bioethics Conference.

With talks on pressing issues by experts in the field, the conference will serve as fertile ground for the development and elucidation of best practices in pediatric bioethics. This conference will include sessions such as Ethical Issues in Forgoing Artificial Nutrition and Hydration, A Child’s Evolving Understanding of Death and Dying, and The Impact of Government Policy on Bioethical Decision Making.
