### **OVERVIEW**

### **Ethics and Health Law**

The Florida legislature, various state administrative agencies, and the courts make and implement public policies on an ongoing basis that significantly affect the health of our population in many ways. The process of health policy making and implementation ought to be based in substantial part on the consideration of relevant ethical principles of social justice, individual autonomy, beneficence (doing good), and *primum non nocere* (avoiding harm). By examining the key policy issues arising in several specific contexts, this program will explore whether and how ethical considerations are taken into account in formulating health policy in Florida.
